Group C (bandages) will be devidid into 2 Groups. Items 5.1 – 5.4 shall constitute Group C1 (stretch gauze) and items 6.1 – 7.2 shall constitute Group C2 (micropore/ transpore). |

Addendum No. 4 states that Group C will be divided into 2 Groups: C1 and C2. It is hereby clarified as follows:

Each Bidder may submit a new Bid for Group C1 and/or Group C2. Such new Bid shall replace his former Bid for Group C, which shall no longer be valid.

Any bidder that does not submit a new Bid for Group C – his former Bid for Group C shall be divided by the Tender Committee into Groups C1 and C2, and shall remain valid according to its terms (subject only to such split into 2 Groups).
